- Jeff & Samira discuss with Gary how to best support Dec 14 holiday hoopla talent show e.g. with snacks; Jeff & Samira will connect after

Access past funds/bank account and Foundation access – Abi

- CRA wants TDSB letterhead stating that President = Chair/Co-Chair, "Toronto Island Public School" = School Council
- E.g. "ex officio the President of the Toronto Island Public School" = "Abi Wren", Co-Chair of IPS School Council
- E-mail Gary what's required & he'll do it
- Jason send Abi draft of CRA-preferred wording to send to Gary

Outdoor Classroom/Playground - Group Discussion

- Spider web replaced, frame was structurally sound, is \$18,000 cost, under warranty / TDSB covering
- There is a store room near the front of the school that Gary wants to put balls & etc. in for kids to have access to
- Outdoor classroom & stumps removed: safety audit by AON (?) global risk management, came Nov 6 to do risk audit of school
- Every time a kid trips or falls we send in a report, was 8 incidents within a matter of days-weeks, were not minor injuries, were concussions & broken fingers
- Due to multiple frequent serious incidents TDSB sent a safety auditor to do a health and safety inspection
- Inspection saw wood was in bad condition, some holes in them that small kids' feet could fit in, they
 ordered the TDSB to remove it
- Outdoor classroom planks had degraded and kids were getting splinters
- Removal company showed up on day Gary was on leave of absence (Human Rights Commissioner work), was an acting principal was on-site that day
- Wood was removed since it was a health & safety issue
- TDSB has to comply with health & safety auditor's findings
- Outdoor classroom is only outdoor play area for kindergarten, is now empty
- Gary trying to get age-appropriate play equipment ASAP
- Lots of kids & parents upset due to surprise removal, missed opportunity to communicate details in advance; original expectation was removal would be in January but it happened much quicker than expected
- Kids came to speak to Gary about the forts & wood being taken away, agreed kids could put up
 pictures & write about what the forts & wood meant to them, would be a permanent installation at the
 school
- Gary: outdoor classroom is part of the school's identity, so it must be put back
- IPS is a nature-based school -- we will bring it back, kids & parents will have a say, we will do
 something with loose parts

- Action items (1) got spider web restored quickly, (2) are working with city & TDSB services to restore facilities for play (3) work with students & parents to install recess & instructional time equipment
- **Would be helpful**: parents write Gary nice, concerned letters asking for instructional & play equipment to be replaced: we need proper play structures for the kids, cc: usual people
 - \circ $\,$ We can form a playground revitalization committee with parents & kids $\,$

- Abi & Samira organize community to write helpful letters

Principal's Report – Gary Pieters

- Questions only, main item was playground changes as above
- Can things be done at principal's school without principal's knowledge? e.g. playground equipment removal on day Gary isn't there
 - Yes, since Gary doesn't manage e.g. playground, fields, boiler room -- those are managed by facilities services, caretaker staff don't report to Gary, report to facilities so are under their direction (same with kitchen, is managed by nutritional services)
- Unrestricted computer use Gary needs to follow up with teacher to ensure computer usage is appropriate & teachers are supervising usage
 - Parents expressed concerns with lack of restrictions on TDSB device internet access
 - Is there a TDSB policy on internet usage? Yes there is:
 - TDSB on-line code of conduct (applies to staff, too)
 - TDSB acceptable use policy
 - If teachers aren't compliant, and is brought to Gary's attention he can follow-up with them
 - Gary will raise this in his staff meeting & week-at-a-glance to staff
 - Subsequent addition: Gary's Dec 11 weekly roundup contained:
 - Responsible Use of Technology at School During Instructional and Non-Instructional Times:
 - Acceptable Use of Information Technologies
